REGISTRATION: Noon BRIEFING: 2.10 p.m. START: 2.30 p.m.

THE COURSE: Rectangular buoyed circuit starting in water 800m east of pier opposite the Langham Hotel, BN22 7AH

WEATHER REPORT: Telephone 01323-733606 between 8.00 a.m. and 9.00 a.m. on the day for confirmation conditions are suitable for the swim to be safely held. In the event of inclement conditions making it unsafe to hold the competition the organisers will make every effort to re-run on another date.

AGE GROUPS: (12~13) (14~16) (17~24) (25~34) (35~44) (45~54) (55~64) (65~74) (75+)
Ages taken as of 31st December 2010

DISABILITY ATHLETES: The event is inclusive of competitors with a disability who must be registered with the ASA, British Swimming and / or the IPC, and hold a valid Functional Ability Card (FAC). Disability athletes will swim under exactly the same conditions as all other competitors.

REGISTRATION: All swimmers must be registered (category 2) members of clubs affiliated to the ASA, the Scottish or Welsh ASA. Overseas competitors must be registered members of clubs in a country affiliated to FINA. All competitors shall have joined the club they are representing at least 60 days prior to the competition.

PRIZES: Trophies will be presented for the first three women and men in each age group + challenge shields for overall fastest male and female. Time certificates will be awarded to all those completing the course

CUT OFF TIME: After 1 hour 15 minutes any swimmers who have not finished will be taken out the water.

ORGANISORS CONDITIONS

(HELD UNDER ASA LAWS AND ASA TECHNICAL RULES INCLUDING IPC RULES FOR A MULTI-DISABILITY EVENT)

- 1) **Course Stewards Briefing:** Swimmers must register by 2.00 p.m. and then attend the safety briefing which will take place on the starting beach at 2.10 p.m.
- 2) **Competitor numbers:** Numbered hats will be provided and must be worn, plus either upper arms or back must display competitor number.
- 3) **Clothes:** Numbered plastic sacks will be provided for clothing and looked after by a steward. Whilst every effort will be made to maintain security it is suggested valuable personal effects are left with non-competing friends.
- 4) **Start:** Will be in the water and signalled by a fog horn and the drop of a flag. All competitors who did not take part in the 2009 race are requested to submit an estimated time. Start waves will be seeded fastest to slowest and any swimmer not providing a time will be started in the slowest wave.
- 5) **Swim Attire:** In addition to the hat provided (which must be worn), goggles, nose clip, and earplugs can be used, but no other equipment which may be considered a buoyancy or insulation aid. Competitors can wear only one costume which shall be in accordance with FINA General Rules on Swimwear, in force on the date of competition. Grease will be allowed subject to the Referee's opinion it has not been excessively applied.
- 6) **Swim Stroke:** This is a freestyle event with no stroke technique requirements.
